SUSTAINABLE AND ENVIRONMENTALLY RESPONSIBLE PRACTICE – CONSERVATION OF NATURAL RESOURCES





This ensures the use of environmentally compatible and safe production techniques, the assurance of health and safety for our partners and employees, and also the sparing use of natural resources.



















ECOLOGICAL ACHIEVEMENTS AND RESPONSIBILITY
